5. About the TMD

This TMD aims to provide an understanding of the class of customers we have designed this product for, being the target market. When considering the target market, we focused on our customers' objectives, financial situation, and needs within this class of people we believe this product to be suitable.

6. Target Market

6.1 Description of target market

The features of this product have been assessed as meeting the likely objectives, financial situation and needs of consumers who:

- are:
- are:
 - at least 18 years old;
 - individual borrowers (as single or joint borrowers); and
 - Non-resident applicants may require approval from the Foreign Investment Review Board (FIRB) before they can purchase real estate.
 - Salary and Wage earners (Employees) and Self-Employed Consumers only (Company and business borrowers are excluded).

- The applicant(s) must provide their passport and a secondary photo identification as identification to satisfy Anti-Money Laundering and Counter-Terrorism Financing Act 2006 (AML/CTF) requirements; and
- Only to borrowers situated in “Approved Countries”
- require a loan to purchase or refinance an investment property;
- require an offset account;
- require the certainty of a fixed interest rate;
- are able to make up to \$20k of extra repayments without penalty; and
- want the option of either principal and interest or interest only repayments.
- satisfy our eligibility criteria;

The product meets the likely objectives, financial situation and needs of consumers in the target market because it provides them with the certainty of a fixed rate for an initial period of time, allows them to deposit funds into an offset account and/or make additional payments directly into the loan to reduce the amount of interest payable up to \$20k additional per annum whilst maintaining the ability to draw on surplus funds when required. This product also allows consumers to select interest only or principal and interest repayments in order to reduce their overall debt and build equity.

6.2 Classes of consumers for who the product may not be suitable

This product may not be suitable for consumers who:

- do not meet the eligibility requirements;
- are looking to construct a property; or
- require the ability to provide alternative methods of income verification.

6.3 Description of the Product, including key attributes

- Fixed interest rate;
- Repayment options:
 - principle and interest; or
 - interest only
- Redraw available
- Able to make up to \$20k of extra repayments without penalty
- Minimum loan size: \$50,000
- Maximum Loan Size: \$900,000 (subject to LVR and postcode policy)
- Maximum LVR – 75%
- Offset facility available
- Application fee is payable
- Settlement fee is payable
- Valuation fee is payable
- Ongoing annual facility fee is payable

The distribution channels and conditions are appropriate because:

- the product has a wide target market;
- our staff have the necessary training, knowledge and accreditation (if required) to assess whether the consumer is within the target market. All of our staff must continually satisfy annual compliance reviews.
- we rely on existing distributors, methods, controls and supervision already in place;
- our approval system has checks and controls in place to flag applicants who may be outside the target market; and
- accredited mortgage brokers are subject to a higher duty under BID to ensure that the product is in the best interests of the particular consumer.
